Online applications are invited from the eligible candidates to appear for All India Common Entrance Test (AICET) for admission under Craft Instructor Training Scheme (CITS) in the following trades at ITI Srinagar for the session 2023-24. The details are given under: -


Date of All India Common Entrance Test: 08.07.2023

Eligibility Qualification: NTC/NAC (NCVT certificate in relevant trade) or Diploma / Degree from a recognized Board of Technical Education/University or equivalent. SCVT candidates are also eligible.


Entrance Examination Fee: Candidates need to remit requisite entrance examination fee online.

Instructions to the candidates

1. The link for online application is available on www.nimionlineadmission.in.
2. The registration facility for Computer based Test is available on the website from 01.06.2023 to 17.06.2023.
3. The eligibility, syllabus for the trades and exam is provided on the website www.nimionlineadmission.in.
4. The candidate can select any entrance examination centre as per his/her convenience and indicate his/her preferences. Exam centres might change based on the number of candidates applying for the particular centre. If very few candidates have opted for an Exam centre, alternate available centre will be provided.
5. The allotment of seats in an institute will be finalized by respective Institute during counselling solely on the basis of merit (marks secured in the AICET) and as per the choices mentioned by the candidate in his application as well as considering the reservation norms.
6. If as per merit, the candidate's preferred seats (choices in application) are not vacant, he/she will be offered seat wherever available.

7. No transfer request for admission will be entertained.
8. Only those candidates who have appeared and qualified in the AICET -2023 as per merit are eligible in NSTIs & IToTs for CITS admission.
9. No walk-in /direct admission will be entertained outside the merit list of AICET in any of the Institutes.
